ORDER

As per the University order 1st read above 48 officers in Kerala Agricultural University have been nominated as Public Information Officers. Vide University order 2nd read above the Deputy Registrar (Admn.) has been nominated as Public Information Officer of KAU. In KAU Headquarters there are two Deputy Registrar in the Administration Wing viz., Deputy Registrar (Admn.) I and Deputy Registrar (Admn.) II.

As per submission 3rd read above, the Deputy Registrar (Admn.) I and Public Information Officer has pointed out that as per Section 5 (1) of Right to Information Act, Public Information officers should be the custodian of information and adequate number of Public Information officers to this effect may be designated. It is also stated that the Deputy Registrar (Admn.) I and Deputy Registrar (Admn.) II are dealing entirely different subject matters whereas Deputy Registrar (Admn.) I alone is acting as Public Information Officer and pointed out the difficulties in this regard.

In these circumstances the following orders are issued.

- (i) Deputy Registrar (Admn.) I and Deputy Registrar (Admn.) II are nominated as Public Information Officers of the concerned Administration Wing.
- (ii) The University order read above stands modified to this extent.
- (iii) All Public Information Officers and Assistant Public Information officers are hereby directed to exhibit their name board as per the provisions in Right to Information Act 2005.
- (iv) All Public Information Officers and Assistant Public Information Officers are hereby informed that they have to act independently as far as the subject matter dealt in by them.
